ELIGIBILITY FOR ADMISSION

NATIONALITY: Only Indian citizens are eligible for admission to professional courses unless otherwise notified.

ACADEMIC:

- ➤ Candidate should have passed Higher Secondary examination conducted by Board of Higher Secondary Education, Kerala, or examination equivalent there to as approved by Kerala University of Health Sciences, Thrissur
- ➤ Should have 50% marks in Physics, Chemistry, Biology and English put together (Rounding off of the percentage of marks to the nearest whole number is not permitted)
- Candidates who have passed their qualifying examinations from the states other than Kerala shall produce the certificate of recognition and equivalence of qualifying examination.

AGE: The applicant should have completed 17 years of age as on 31-12-2025.

- 2. SSLC / equivalent certificate to prove date of birth.
- 3. Mark list(s) of the qualifying examination.
- 4. Conduct certificate
- 5. Certificates as proof in support of any claim for special reservation.
- 6. Candidates applying under the 'Persons with Disabilities' category must submit a medical certificate from the District Medical Board, obtained within 3 months before the final date of application submission.
- 7. Community certificate obtained from revenue authority, if claiming seats reserved for minority communities.
- 8. Transfer Certificate (TC) from the Institution last attended and Conduct Certificate.
- 9. Relieving Order from the Department concerned, if applicable.
- 10. migration Certificate, if applicable.
- 11. Income certificate from concerned revenue authority.
- 12. Physical Fitness Certificate in the relevant format.
- 13. A Certificate showing that the candidate has got himself/herself vaccinated against Hepatitis.
- 14. Anti-Ragging undertaking in the given format duly signed by parent & candidate.
- 15. Any other document as required by the Head of Institution.

PROCEDURE FOR SELECTION

Selection will be based on the rank list prepared on the basis of marks obtained in Physics, Chemistry and Biology and English put together in the qualifying examination.

In case of a tie in the total marks computed for ranking, candidates with higher marks obtained in Biology will be placed higher in the ranking. If the tie still exists, the candidate with higher marks obtained in Chemistry will be placed higher in the ranking. If the tie still exists, the candidate with higher marks obtained in Physics will be placed higher in the ranking. If the tie still exists, the percentage of total marks for the qualifying examination and then the percentage of marks in English in the qualifying examination will be considered for breaking the tie. Even after this, if tie

remains, the age of the candidate will be taken into account and the older will be placed higher in ranking than the younger. If the tie still persists, the alphabetical order of the names of the candidates in English will be taken into account (eg. 'A' has a higher priority than 'B' and so on)

- Furnishing false information or particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course. In addition, it will invite the relevant provisions of the criminal law of the land.
- After scrutiny of applications, merit list of the different categories will be published in the website thiruvananthapuram.rkmm.org and in the notice boards of the college. Selection will be strictly in the order of merit. Selected candidates will be intimated through email but are advised to refer college notice boards and appear for the interview and final selection without fail.

ADMISSION

- For genuine reasons, principal will have the right to deny admission to any candidate even if otherwise eligible.
- No marks will be allotted for interview.
- > Selected candidates shall take admission at the appointed time and date in the college after paying the admission fee, 01st year tuition fee, special fee, caution deposit etc, failing which the offer of admission will be cancelled.

In case of students who leave the college midway, the right of the management for liquidated damages if any, from such students shall be determined by appropriate proceedings before the competent Forum/Civil Court.

REFUND OF FEES

After closure of admissions, the seat if vacated cannot be filled up. Such seats will go vacant for the entire duration of the course. Therefore, those who leave the course after the closure of admissions will have to pay liquidated damages equivalent to the tuition's fees for the remaining period of the course. Any complaints in this regard will be addressed by appropriate proceedings before the competent Forum/Civil Court. The college shall return the Certificate and TC of these students, on execution of a bond by the student along with any of his/her Parents, undertaking to pay the amount that maybe ordered by the competent Forum/Civil Court. Those who leave the course after commencement of classes, but before closure of admissions, tuition fees will be refunded provided the institution could fill up the vacancy.
